

# Terms of Use

Effective Date: March 30, 2026

## 1. Acceptance of Terms

These Terms of Use ("Terms") govern your use of the KinStreak mobile application ("the App") provided by Xadrez Inverso LDA, operating as FATFIRE Apps ("we", "us", or "our"). By downloading, installing, or using the App, you agree to be bound by these Terms. If you do not agree, please do not use the App.

## 2. Description of the App

KinStreak is a self-help tool designed to help parents build calmer habits through daily check-ins, breathing exercises, guided reflection, and streak tracking. The App is intended for personal, non-commercial use.

## 3. License

We grant you a limited, non-exclusive, non-transferable, revocable license to use the App on any Apple device that you own or control, subject to these Terms and the Apple Media Services Terms and Conditions.

## 4. Subscriptions and Payments

The App offers auto-renewable subscription plans that provide access to premium features. Subscriptions are billed through your Apple ID account and managed entirely by Apple.

Payment is charged to your Apple ID account at confirmation of purchase. Subscriptions automatically renew unless cancelled at least 24 hours before the end of the current billing period. You can manage or cancel your subscription at any time through your device's Settings > Apple ID > Subscriptions.

Prices may vary by region and are displayed in your local currency in the App Store. We reserve the right to change subscription pricing; any price change will take effect at the start of the next billing period following notice.

## 5. User Content

You retain ownership of any content you create within the App, including journal entries and letters. This content is stored locally on your device and is not transmitted to us. We have no access to, and assume no responsibility for, your user-created content.

## 6. Intellectual Property

The App, including its design, code, graphics, text, and all other materials, is owned by Xadrez Inverso LDA and protected by applicable intellectual property laws. You may not copy, modify, distribute, sell, or lease any part of the App, nor may you reverse-engineer or attempt to extract the source code.
